## Letter of Support for the 2024 BIP Program: Reconstruction of 40th Avenue North **Bridges Over Interstate 29 & BNSF Railway**

As Governor of North Dakota, it is a privilege to express support for the North Dakota Department of Transportation (NDDOT) for funding through the United States Department of Transportation's Bridge Investment Program (BIP). The BIP funding would facilitate completion of the long-planned replacement of two bridges along 40th Avenue North, located over Interstate 29 (I-29) and BNSF railroad in Fargo, N.D.

Both bridges along 40th Avenue North are approximately 840 feet apart. One bridge spans the BNSF rail lines while the other bridge spans I-29 to the west. The vertical alignment of 40th Avenue North as it crosses the railroad creates sight distance challenges and confusion for westbound vehicles. This leads to unsafe travel conditions as drivers erroneously attempt to make a "wrong way" left turn at the northbound ramp, which contributes to the severity of crashes at this location.

The bridges are critical pieces of the region's intermodal freight network, providing direct access across I-29 to air cargo operations and the region's primary industrial growth area. As Fargo and the surrounding region continues to grow and freight traffic continues to increase transportation challenges, these improvements will address these challenges and strengthen the transportation system, sustaining the growth of Fargo, the region and North Dakota.

We support the NDDOT's application for the Reconstruction of 40th Avenue North Bridges Over Interstate 29 & BNSF Railway Project. We appreciate your consideration of our request, as this project is vital to our state, the region and the global economic community.

We write to express our support for the North Dakota Department of Transportation's (NDDOT) Bridge Investment Program (BIP) grant application for the 40<sup>th</sup> Avenue North Bridges Project. Thank you for your consideration.

Metro COG is the federally-designated Metropolitan Planning Organization (MPO) for the Fargo-Moorhead area, responsible for developing the federally recognized Metropolitan Transportation Plan and the programming of federal transportation funds within the Metro COG Planning Area, which includes the City of Fargo in Cass County, North Dakota.

Cass Highway 20 is west, and Cass Highway 81 is North-East this interchange. Future improvements are planned in the next 3-10 years, if HSIP funding is available then construction improvements would take place in 2026 to Cass Highway 20 that include road widening 3 miles to the west; along with roundabout intersection improvements 1 mile to the west at 45<sup>th</sup> St. and 3 miles to the west at County Hwy 17, along with the resurfacing Cass Highway 81 to the east to accommodate the increased future traffic needs.

The Cass County Commissioners, County Administrator, Finance Director and myself the County Engineer fully support the NDDOT's application for the funding of Reconstruction of 40th Avenue North Bridges Project and look forward to the infrastructure investment in our region through the Bipartisan Infrastructure Law.
