Dear Secretary Buttigieg:

On behalf of the entire Crow Wing County Board of Commissioners, I am writing to support the Minnesota Department of Transportation's application for federal funding through the Consolidated Rail Infrastructure and Safety Improvements (CRISI) Discretionary Grant Program.

The junction of State Highway (Hwy) 371 and Hwy 210 plays an important role in this County's overall transportation and freight network. Over the last two decades this intersection has experienced large increases in traffic demand and corresponding challenges related to elevated levels of crashes and congestion. With well over 50,000 vehicles utilizing this facility each day, it has been classified as the busiest at-grade intersection in central region of Minnesota. It also ranks among the very highest in the state as it relates to the total cost of crashes that occur each year. Among the complicating factors is the location of an at-grade Burlington Northern and Santa Fe (BNSF) railroad crossing less than 300 feet south of the intersection of this two high-volume state highways.

Over the last several years, Crow Wing County and its agency partners have worked closely to raise awareness of this challenging intersection and its complicating factors. A preliminary engineering review completed in 2022 revealed a range of feasible grade-separated alternatives able to improve the failing intersection and eliminate the challenging railroad crossing. The in-depth engineering and environmental review needed to identify and design a specific solution is critically important to our county and the entire central lakes region of Minnesota.

Crow Wing County is fully supportive of MnDOT's effort to seek funding assistance to advance this important project. I ask that you give MnDOT's application for federal CRISI funding your full attention and favorable consideration.
