


Figure 1: V18/South White St. at City of Alta Vista South Corporate Limits (Facing North)




Figure 2: V18/South White St. Typical Pavement Deterioration (Facing North)




Figure 4:South White St. (Facing North)




Figure 23:South White St. existing pavement deterioration next to Linden Park/Veterans Memorial (Facing Northeast)




Figure 24:South White St. existing pavement deterioration/sidewalk/curb next to Linden Park/Veterans Memorial (Facing Northeast)




Figure 26:South White St. existing pavement deterioration next to Security State Bank/Alta Vista Insurance (Facing Northwest)




Figure 47:V18/110th St. existing pavement deterioration (Facing East)




Figure 49:V18/110th St. existing pavement deterioration approaching intersection of Fayette Ave./110th St. (Facing West)




Figure 51: V18/Fayette Ave. approacing 110th St./V18 (Facing South)
