Dear Secretary Buttigieg:

I write in support of the Minnesota Department of Transportation's application for funding through the United States Department of Transportation's Rural Surface Transportation Program. If awarded, funding would support the Highway 210 Brainerd, Minnesota – Equity, Safety, and Multimodal Connectivity Project, which would address critical access and safety concerns, enhance connectivity, and improve the regional transportation network in central Minnesota.

State Highway 210 in Minnesota is a vital arterial route that runs from the Minnesota-North Dakota border through central Minnesota to Lake Superior, connecting the city of Brainerd and the Central Lakes region to other parts of the state. It plays an essential role in supporting commuters, freight movement, commercial transportation, and recreational travel. The highway is also vital to the local economy and a robust regional tourism industry; bringing visitors to the Central Lakes region and connecting its rural communities with the rest of the state. However, State Highway 210 in Brainerd is currently an outdated highway with serious access, mobility, and safety concerns; which negatively impacts freight movement, local economic development, and growth along the corridor.

Funding from the United States Department of Transportation would be used to reconstruct portions of State Highway 210, install accessible multiuse sidewalks, ramps, crosswalks, and trails along the corridor; rehabilitate a bridge, construct new roundabouts, and upgrade aging utility and storm water infrastructure. These improvements would address critical access and safety concerns, increase capacity, update aging infrastructure, and boost local economic development. If approved, this project would support the needs of rural Minnesotans by cutting commute times, boosting businesses and tourism in the region, and improving public safety.

WHEREAS, the Multimodal Project Discretionary Grant (MPDG) program provides dedicated funding for transportation infrastructure projects intended to increase equity, safety, and multimodal system connectivity, and

WHEREAS, the United States Department of Transportation (USDOT) is soliciting applications for \$5.5 billion for the FY 2023-2024 MPDG program as appropriated through the Bipartisan Infrastructure Law (BIL) under the National Infrastructure Investments and 2023 Appropriations Act (IIJA), and

WHEREAS, eligible projects for FY 2023-2024 MPDG program include surface transportation capital projects including highway, bridge, or other road projects, and

WHEREAS, Minnesota Department of Transportation (MnDOT) intends to apply for MPDG program funds for a project named MN 210 in Brainerd - Equity, Safety, and Multimodal Connectivity Project, and

WHEREAS, MnDOT, the City of Brainerd, Crow Wing County, and other public and private partners have collaborated to develop a community supported improvement project on a four-mile segment of Minnesota Highway 210 (MN 210) from Baxter Drive to Pine Shores Road in Brainerd, and

WHEREAS, the proposed project will improve freight movement through the region while simultaneously diminishing the risk of fatal and serious injury crashes by reducing conflict points and enhancing several key intersections, and

WHEREAS, the proposed project will also increase mobility and multimodal opportunities by creating a network of multiuse sidewalks, curb ramps, crosswalks, and trails accessible by underserved populations and users of all abilities, and allow for the rehabilitation of the bridge over the Mississippi River as well as allow the City of Brainerd to make critical improvements to aging public utility and storm water systems, and

WHEREAS, MnDOT intends to apply for \$25.0 million of MPDG program funds to supplement existing funding streams and assist local agencies to meet future financial obligations associated with the project, and

WHEREAS, the County will incur a financial obligation associated with proposed intersection improvements at the junctions of MN 210 and County State Aid Highway 3 (CSAH 3) and CSAH 45, and

WHEREAS, an estimate of the County's financial obligation has been identified utilizing MnDOT's current cost participation policy and is included in Crow Wing County's 2023-2027 Five-Year Highway Improvement Plan, and

WHEREAS, if MPDG program funds are awarded to this project, Crow Wing County expects that MnDOT will equitably apply the benefits of the grant funds to the financial obligation incurred by the County as defined by MnDOT's cost participation policy in place at the time of construction, and

WHEREAS, Crow Wing County agrees to own and properly maintain the portions of the proposed project transferred to the permanent jurisdiction of the County after the project is complete.

NOW, THEREFORE, BE IT RESOLVED the Board of Commissioners of Crow Wing County, Minnesota, supports MnDOT's application for the FY 2023-2024 MPDG program funds for MN 210 in Brainerd - Equity, Safety, and Multimodal Connectivity Project with the expectation that any awarded funds be equitably applied to the County's financial obligation as defined by MnDOT's cost participation policy in place at the time of construction.

On behalf of the entire Crow Wing County Board of Commissioners, I am writing to support the Minnesota Department of Transportation's (MnDOT) application for the FY 2023-2024 rural Multimodal Project Discretionary Grant (MPDG) program for the Hwy 210 Brainerd, MN – Equity, Safety, and Multimodal Connectivity Project.

Over the last several years, Crow Wing County has worked closely with MnDOT to study and develop strategies to improve the local portions of MN 210. This east-west corridor functions as an important link for the municipal and county road systems. It also plays a critical role in Minnesota's overall transportation network that connects the twin ports area of Duluth to important freight destinations around the region.

Currently, the four-mile segment passing through Brainerd experiences the highest volumes of traffic and associated levels of congestion of all roadways within Crow Wing County. This combined with limited accommodations for pedestrians, bicyclists, and other multimodal users, makes it challenging to safely travel along or to cross this portion MN 210.

Crow Wing County's partnership with MnDOT continues to be part of a much larger collection of stakeholders including the cities of Brainerd, Baxter, and a number of other public and private partners. Over the last year, this level of collaboration and public outreach produced a community supported alternative ready for advancement to the next phases of engineering and construction. It achieves a thoughtful balance between the needs of the local residents and those required to sustain MN 210 as a major commuter and freight corridor.

An award of funding from the MPDG program will ensure the timely reconstruction of this critical segment of MN 210. The proposed improvements are designed to decrease congestion and increase safety by reducing conflict points and installing roundabouts at two key intersections. Likewise, it will create a continuous network of multiuse sidewalk, curb ramps, crosswalks, and trails, accessible by underserved populations and users of all abilities. Additionally, the project will provide an opportunity to rehabilitate the corridor's only bridge over the Mississippi River and allow the City of Brainerd to make critical improvements to its aging public utilities and stormwater systems.

# RE: Letter of Support for the FY 2023-2024 MPDG Rural Grant Program: Highway 210 Brainerd, Minnesota – Equity, Safety, and Multimodal Connectivity Project

Dear Secretary Buttigieg:

On behalf of our 1,100 members, I am writing in support of the Minnesota Department of Transportation (MnDOT) District 3's application for MPDG Rural Grant Program funding to address safety and accessibility concerns in the Brainerd Lakes Area of central Minnesota.

Hwy 210 through Brainerd is an important corridor for statewide users, the commuting public, freight, and those accessing regional destinations. It has the highest traffic volumes in Crow Wing County and is the only continuous east-west corridor in Brainerd. There are currently limited provisions for pedestrians and bicyclists to travel along or cross-over the corridor.

The MPDG Rural funding would reconstruct a four-mile segment of Highway 210, construct a network of ADA-accessible multiuse sidewalks ramps, crosswalks, and trails; rehabilitate the bridge over the Mississippi River; construct two new roundabouts; and upgrade aging utility and stormwater infrastructure. In addition, improved aesthetics will complement our brand as a vacation destination.

MnDOT District 3 spans a large swath of central Minnesota. The project is important to our regional economy as it supports key industries as well as consumers across the state. The project provides multimodal connectivity and increases safety and travel time reliability so residents and visitors of all backgrounds, incomes, and abilities may access jobs, recreation, and housing.

The improvements due to the project will serve to improve traffic flow, provide safer streets, repair aging infrastructure, expand multimodal access, and improve overall appeal in and around the project area. We support MnDOT's application and look forward to infrastructure investment in our region.
