I write today to request full and fair consideration of the South Dakota Department of Transportation's (SD DOT) Rebuilding American Infrastructure with Sustainability and Equity (RAISE) grant application for the reconstruction of U.S. Highway 12. This project highlights the importance of the Rural Opportunities to Use Transportation for Economic Success (ROUTES) Initiative and also meets RAISE's goal of funding projects that will have a significant local or regional impact.

The project will reconstruct U.S. Highway 12 from Morristown east to Watauga for 9 miles. The reconstruction will widen the shoulders, increase safety along the corridor and replace a bridge currently in poor condition. It is a significant highway on the Standing Rock Reservation and in Corson County, providing vital east-west access through a designated area of persistent poverty. If this project is completed, it will help support economic vitality for both tribal and non-tribal communities in this region.
