RESOLUTION NO. 12-2024

Upon a motion by Representative May and second by Representative Cobenais, the following was enacted:

WHEREAS, the Red Lake Tribal Council is the duly elected governing body of the Red Lake Band of Chippewa Indians; and the Tribal Council has the authority and the responsibility to provide for the safety, health and welfare of its members; and

WHEREAS the Red Lake Tribal Council establishes and revises the reservation road construction priorities from time to time; and

WHEREAS, in order to better meet the needs of the Red Lake Reservation, a revised priority list needs to be established. Now

THEREFORE BE IT RESOLVED, that the Red Lake Tribal Council hereby revises the Reservation Road Construction Priority list to provide an updated list of the Indian Reservation Roads (IRR) construction projects on the Red Lake Indian Reservation and requests the Bureau of Indian Affairs take the necessary action to include these projects in the Transportation Improvement Plan.

The Red Lake Nation Transportation Priorities are as follows:

- Indian Services Routes 170, 171, 172 & 173, Red Lake Streets East (North of Hwy. 1). Reconstruct 0.9 miles of Community Streets.
- 2. Indian Service Route No. 40, Nebish/Redby Road bituminous resurfacing
- 3. Indian Service Route No. 225, Mendota Avenue (Oshkiimaajitahdah). Reconstruct 0.3 miles Street.
- 4. Indian Service Routes 136, 137, 138, & 139, Red Lake Streets (BOT). Reconstruct 3.1 Miles of Community Streets.
- 5. Indian Service Route No.174, Thunder Lake Road East (Phase III) (Complete project from end of Phase II to I.S. No. 40 & 18)-grade, drain, gravel base and bituminous surfacing.
