I am pleased to support the City of Madison's application for the Safe Streets and Roads for All (SS4A) grant program through the Department of Transportation. It is my understanding the City of Madison is requesting \$16 million in federal discretionary assistance to support local efforts to prevent deaths and serious injuries involving all roadway users. If awarded, funding would be leveraged with a \$4 million local match for implementing infrastructural, behavioral, and operational initiatives and for supplementing defined Action Plan activities to further improve and update the existing plans.

The Madison Common Council adopted Madison's Vision Zero goal in July 2020. The resulting Vision Zero Madison plan was officially adopted in March 2022. Its goal is to eliminate all fatalities and severe injuries that occur as the result of traffic collisions on city streets by 2035. However, despite those local commitments, residents in Dane County nevertheless contend with the second-highest average number of traffic fatalities per county statewide.

According to City of Madison officials, a prioritization list of projects and strategies was developed to: "implement traffic safety measures in a fair and equitable manner on city streets; improve connectivity by closing gaps in the city's pedestrian and bicycle networks in a fair and equitable manner, and ensure that pedestrian and bicycle networks are accessible for all ages and abilities." The requested federal grant would be used to implement infrastructure improvements to 42 unique locations, 33 operational and behavioral initiatives, and six planning activities. Per the City, 24 projects are located in disadvantaged communities across USDOT Priority Census Tracts.

I strongly support proposals that improve the safety and accessibility of Wisconsin's transportation infrastructure, benefiting residents and our communities at large. For this reason, I respectfully request that full and fair consideration be given to the City of Madison's SS4A application. I write on behalf of the City of Madison and its grant application to the U.S. Department of Transportation Safe Streets and Roads for All (SS4A) Program. I understand the request is for \$16 million worth of federal discretionary assistance to support local efforts to prevent deaths and serious injuries involving roadway users. The CFDA number for this program is 20.939.

Unfortunately, Dane County has the second-highest average number of traffic fatalities per county in the State of Wisconsin. In response to this, Madison was the first city in Wisconsin to join the Vision Zero Network. The Vision Zero Madison plan was officially adopted in March 2022, with a stated goal of eliminating all fatalities and severe injuries that occur due to traffic collisions on city streets by 2035. A funding award will support the implementation of infrastructural, behavioral, and operational initiatives as well as to supplement defined Action Plan activities that improve and update existing plans.

The requested federal grant would be used to implement infrastructure improvements to 42 unique locations, 33 operational and behavioral initiatives, and six planning activities. 24 of the projects are located in disadvantaged communities across USDOT Priority Census Tracts. The sites included in this project were selected to ensure that the city's streets and pedestrian and bicycle networks offer accessibility and equity to all users.

I am supportive of this and other efforts to improve safety for all residents, commuters, and visitors on local roadways. I ask that this application receive full and fair consideration for funding. 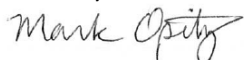

A recent report from the Dane County Traffic Safety Commission noted that there were 80 automobile crashes between January and June 2022 involving alcohol, 41% more than the five-year average. Of those, 16 were fatal, including 11 that involved drivers whose blood alcohol levels exceeded the legal limit of 0.08%. PHMDC is committed to helping create safe streets and roads in the City of Madison by implementing public health alcohol harm reduction strategies within the context of this grant application.

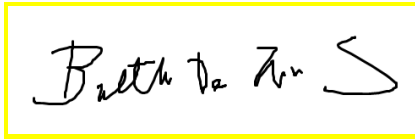

AARP Wisconsin is writing with respect to the City of Madison's Forward to Vision Zero application for a U.S. Department of Transportation Safe Streets and Roads for All (SS4A) grant to deploy a number of projects throughout the city. The City anticipates the SS4A projects will enable Madison to advance its Vision Zero Action Plan focusing on safety, accessibility, connectivity, and equity across the City of Madison. The City's application is worthy of your consideration.

The corridors that have been selected for this project cross multiple neighborhoods within the city and represent federal and local priority areas, many of which have a high population of residents age 50+.

In addition to focusing on underserved neighborhoods, this project's pedestrian safety improvements and accessible pedestrian signals are anticipated to particularly benefit people without access to an automobile, persons with limited mobility, and persons with vision- or hearing-related disabilities. Safer and walkable streets help connect people to economic and social opportunities. Improvements to walking, biking, and transit infrastructure that increase safety for all road users also encourage travel by non-automobile modes, reducing single-occupancy vehicle trips and vehicle miles traveled.

In 2022, the City of Madison adopted a Vision Zero Action Plan, which AARP Wisconsin was part of the steering committee, to ensure that streets are safe and comfortable for all people, regardless of age, mode, or ability.

For the past 3 years, AARP Wisconsin has worked closely with the City of Madison, and its partners, on pedestrian safety for the older members of our community as part of AARP's Network of Age-Friendly States and Communities. AAA – The Auto Club Group strongly supports the City of Madison’s application for funding through the United States Department of Transportation’s Safe Streets and Roads for All Grant Program.

In a recently released research brief, the AAA Foundation for Traffic Safety found that crash fatalities have disproportionately risen in urban areas of the United States in the last decade, and now exceed the fatality totals of rural areas. Madison, Wisconsin is a vivid example of this trend. Crash fatalities in the City of Madison increased 55% between 2019 and 2021, compared to 7% for the rest of Wisconsin. Addressing traffic safety in cities like Madison is essential to reversing state and national trends.

AAA is a member of the Vision Zero Madison Stakeholder Task Force, and we are confident that their planning initiatives can make a meaningful impact and reduce fatalities. We hope you will consider funding the City of Madison’s proposal.
